## Community Spotlight

### **THE DEAF HEALTH CHARITY SIGNHEALTH**

Among providers of domestic abuse services, SignHealth provides the only Deaf Domestic Abuse Service in the UK, providing support and advice in BSL to Deaf people and children at risk of, or experiencing, Domestic Abuse.

Currently focused on Greater London and some southern counties, their Domestic Abuse team of Deaf staff consist of; Independent Domestic Violence Advisors, Young People Advocates and a Children and Families Worker who provide culturally sensitive services supporting Deaf individuals through leaving violent or abusive relationships and building up their resilience. The team also deliver an educational/preventative service for deaf children/young people, through workshops at schools for Deaf children.

### **A Realist Review of Which Advocacy Interventions Work for Which Abused Women Under What Circumstances - Rivas et al**

This systematic review assesses advocacy interventions for intimate partner abuse in women. The authors conclude that advocacy could have benefits for abused women if undertaken for long enough but highlighted the necessity for the intervention to match the needs of the woman. ### **"Only when it starts crumbling down, that's when you'll know": The role of trade union officers and reps in supporting employees who are experiencing domestic violence/abuse. – Bennett et al**

This executive summary addresses the key findings of a two-phase research project into the role of trade union officers and representatives in supporting employees who are experiencing domestic violence/abuse. They highlight the need for specific domestic violence/abuse policies in the workplace and suggest a 'toolkit' approach to guide individuals through actions and support. ### **Maternal outcomes associated to psychological and physical intimate partner violence during pregnancy: A cohort study and multivariate analysis. – de-Las-Heras et al**

This study evaluates whether the experience of psychological and physical intimate partner violence adversely affects pregnancy outcomes by establishing a cohort of 779 mothers receiving antenatal care in 15 hospitals across Andalusia. They found that psychological IPV was associated significantly with UTI's and spontaneous preterm labour while physical IPV

was associated with antenatal hospitalisations. To read the full article published in *PLoS One* [open access] [click here](#).

### **Cyber-Defence: A Taxonomy of Tactics for Managing Cyberstalking – Tokunaga & Aune**

This study explores how victims respond to cyberstalking. Findings indicated that victims used seven general management tactics of which ignore/avoidance, active technological disassociation, and help seeking were the most common. Using technology to move away from pursuers was reported as the most effective tactic for managing the unwanted relational pursuit.
