Maytree are a national suicide charity that run a one off, short stay, non-medical respite centre in Finsbury Park, for individuals experiencing suicidal ideation. The ethos of Maytree is centred around a holistic and person-centred approach to mental health/wellbeing. The respite centre has been home to over 1600 guests and is a safe and nurturing space for guests, where guests can find understanding, kindness and non-judgement. A Qualitative Study of Sexual Assault Survivor's Post-Assault Legal System Experiences

Lorenz et al

This study looks at the post-assault experiences of 28 survivors and 13 support providers with the criminal and civil legal system. They found that when deciding whether to report their assault to the police, survivors considered institutional biases, perceptions of the police and the perceived strength of their case. Reasons for legal involvement often extended beyond perpetrator prosecutions, such as filing for child custody or seeking financial compensation. Coercive Control: Update and Review - Stark & Hester

This article reviews the background, introduction, and critical response to new criminal offenses of coercive control in England/Wales and Scotland. They review new evidence on the link between control and violence, the measurement of coercive control as well as same-sex and children's experiences of coercive control. Sleep and women intimate partner victimization: prevalence, effects and good practices in health care settings – Matos & Goncalves

Sleep disturbances are an important symptom when diagnosing post-traumatic stress disorder, depression or anxiety. This article discusses how the identification of sleep disturbances in patients can help health professionals to identify potential victims of intimate partner violence, and discusses potential personal and organisational barriers to disclosure that survivors may face. Poor antenatal care attendance is associated with intimate partner violence: Multivariate analysis of a pregnancy cohort – Martin-de-las-Heras et al

This study looked at a cohort of 779 mothers who received antenatal care in hospitals in Andalusia, Spain. They found that poor antenatal clinical attendance was associated with both physical and psychological intimate partner violence.
